#### RESOLUTIONS

Mr. Underwood made a motion to approve <u>Resolution No. 2011-051</u> a Resolution of the Municipality of Penn Hills, County of Allegheny, Commonwealth of Pennsylvania, designating Energy Savers, Inc. to seek energy providers, to negotiate rates, and manage energy programs for the Municipality.

There being no further discussion the motion was approved by a 4-0 vote.

Mr. Palumbo made a motion to approve <u>Resolution No. 2011-052</u> a Resolution of the Municipality of Penn Hills, County of Allegheny, Commonwealth of Pennsylvania, awarding a contract contingent upon final approval by The Pennsylvania Department of Environmental Protection to Pampena Landscaping and Construction, Inc. in the total amount of \$97,015.00 for The Madison Avenue and Storm Sewer Project.
