Here comes Mr. Means from the Progress - I just wanted to make a correction for the Progress they noted that the sewage treatment rates to double in Penn Hills there is a correction on that actually it just went up \$3.85 and it did not double so I am not sure why they put that in the paper and I just wanted to make a correction on that. The service charge was increased back to what it was \$15.00 to \$30.00 but the rate itself did not double.

Dr. Kincaid - thank you very much Mr. Rayan and I would hope that all persons that have influence in and have contact with our citizens would help us get that word out and maybe there will be a retraction in a future paper but of course if people don't read a future paper this is what the people will go with and we do want them to have correct information.
