Sealed Proposals will be received by the Municipality of Penn Hills, Allegheny County, Pennsylvania until 11:00 a.m. on June 20, 2019 to be publicly opened and read immediately thereafter for the following project:

2019 PENN HILLS CD ROAD PROGRAM

This project includes the following approximate quantities:

BASE BID

Approximately 12,750 S.Y. of 2" Maximum Depth Profile Milling, 700 S.Y. of Soft Spot Repair, 1,150 tons of 3/4" 9.5mm Leveling Course, 12,750 S.Y. of 1-1/2" Superpave 9.5mm Fine Graded Wearing Course, 9,000 Lineal Feet of Asphalt Wedge Curb, 1 Storm Sewer Inlet Replacement, 175 LF of Underdrain, Traffic Control, Resident Notification, and Restoration.

ADD ALTERNATE NO. 1 – PENN HILLS SERVICES ASSOCIATION PARKING LOT

Approximately 810 S.Y. of Full Depth Reconstruction, 810 S.Y. of 1-1/2" Superpave 9.5mm Fine Graded Wearing Course, 175 Lineal Feet of Asphalt Wedge Curb, 1 Storm Sewer Inlet, 2 Storm Sewer Manholes, 200 LF of 15" SLCPP, 1 EA Level Spreader, 1 EA Dumpster Pad, Traffic Control, Resident Notification, and Restoration.

ADD ALTERNATE NO. 2 – PENN HILLS SERVICES ASSOCIATION PARKING LOT

Approximately 400 S.Y. of Full Depth Reconstruction, 400 S.Y. of 1-1/2" Superpave 9.5mm Fine Graded Wearing Course, Traffic Control, Resident Notification, and Restoration.

All bidders shall be PennDOT pre-qualified and submit their PennDOT Pre-Qualification Certificates as well as the Anti-Collusion Affidavit with the Proposal in order for the Proposal to be considered responsive.

All Proposals must be in the hands of the Purchasing Department, Municipality of Penn Hills, 102 Duff Road, Penn Hills, PA 15235, by 11:00 a.m. prevailing time, June 20, 2019.

Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words "**2019 PENN HILLS CD ROAD PROGRAM.**"

Copies of Drawings, Specifications, Instructions to Bidders, General Conditions, Forms of Proposals and Agreement are on file and open to public inspection at the Penn Hills Purchasing Office, located at 102 Duff Road, Penn Hills, PA 15235 where sets of said documents may be obtained upon payment of \$50.00 per set. No refund will be made for the return of any documents.

Davis-Bacon Wage rates are required to be paid on this project.

There will be a non-mandatory pre-bid meeting on June 12, 2019 at 11:30 a.m. at the Municipality of Penn Hills Council Chambers, 102 Duff Road, Penn Hills, PA 15147.

Proposals must be submitted on the forms provided by the Municipality of Penn Hills. Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of the Municipality of Penn Hills in an amount equal to ten percent (10%) of the total amount of the Proposal as a guarantee that,

if the Proposal is accepted, the successful Bidder will enter into an Agreement within 15 days after Notice of the Award of the Contract.

The Proposals must be made to the Municipality of Penn Hills, Allegheny County, Pennsylvania, and shall remain firm for a period of one hundred and twenty (120) days. No Bidder may withdraw his Proposal during the one hundred and twenty (120) day period without forfeiting his Bid guarantee.

Performance, Maintenance, and Labor and Material Payment Bonds, along with Public Liability and Property Damage Certificates of Insurance in the amounts specified, as well as Certificates of Workman's Compensation must be filed with the executed Agreement upon acceptance of the Proposal from the successful Bidder.

The Owner reserves the right to reject any or all Proposals, or any part thereof, for any reason, and also reserves the right to waive any informality therein.
