Sealed Proposals will be received by the Municipality of Penn Hills, Allegheny County, Pennsylvania until 10:00A.M. on Thursday, February 21, 2019 to be publicly opened and read immediately thereafter for the following project:

WILLIAM MCKINLEY CENTER DRAINAGE IMPROVEMENTS

This project involves the installation of a foundation drain, waterproofing on existing foundation walls, asphalt trench repaving, and sidewalk demolition and replacement at the rear of the facility.

All Proposals must be in the hands of Stephanie Scaglione, Purchasing Division, Municipality of Penn Hills, 102 Duff Road, Pittsburgh, PA 15235, by 10:00A.M., prevailing time on, Thursday, February 21, 2019.

Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words "WILLIAM MCKINLEY CENTER DRAINAGE IMPROVEMENTS."

Copies of Drawings, Specifications, Instructions to Bidders, General Conditions, Forms of Proposals and Agreement are on file and open to public inspection at the Penn Hills Purchasing Office, located at 102 Duff Road, Pittsburgh, PA 15235 where sets of said documents may be obtained upon payment of \$50.00 per set. No refund will be made for the return of any documents.

Prevailing wage rates are required to be paid on this project.

There will be a pre-bid meeting on February 07, 2019 at 10:00A.M. at the William McKinley Senior Center, 801 Center Avenue, Verona, PA 15147.

Proposals must be submitted on the forms provided by the Municipality of Penn Hills. Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of the Municipality of Penn Hills in an amount equal to ten percent (10%) of the total amount of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within 15 days after Notice of the Award of the Contract.

The Proposals must be made to the Municipality of Penn Hills, Allegheny County, Pennsylvania, and shall remain firm for a period of one hundred twenty (120) days. No Bidder may withdraw his Proposal during the one hundred twenty (120) day period without forfeiting his Bid guarantee.

Performance, Maintenance, and Labor and Material Payment Bonds, along with Public Liability and Property Damage Certificates of Insurance in the amounts specified, as well as Certificates of Workman's Compensation must be filed with the executed Agreement upon acceptance of the Proposal from the successful Bidder.

The Owner reserves the right to reject any or all Proposals, or any part thereof, for any reason, and also reserves the right to waive any informality therein.
