

**NOTICE TO BIDDERS**  
MUNICIPALITY OF PENN HILLS  
ALLEGHENY COUNTY, PENNSYLVANIA

Sealed proposals will be received by the Municipality of Penn Hills, Allegheny County, PA until 10:30 a.m. on February 26, 2021 to be publicly opened and read immediately thereafter for the following project:

**PENN HILLS 2021 CCTV INSPECTION CONTRACTS**

**Contract A**

This project consists of light cleaning and close-circuit televising (CCTV) inspection of approximately 95,000 L.F. of 8” – 30+” sanitary sewers, including heavy cleaning as needed and traffic control, etc., complete in place. All work will be conducted within the Municipality of Penn Hills.

**Contract B**

This project consists of light cleaning and closed-circuit televising (CCTV) inspection of approximately 88,000 L.F. of 8” – 18” sanitary sewers, including heavy cleaning as needed and traffic control, etc., complete in place. All work will be conducted within the Municipality of Penn Hills.

**Contracts A and B are separate and independent. Bidders may bid on all three or any combination of the Contracts. Contracts will be awarded to the lowest responsible bidder for each Contract. Separate Bid Bonds must be submitted for each Contract on which the Bidder intends on bidding.**

All Proposals must be delivered to the Municipality of Penn Hills Purchasing Office, Municipality of Penn Hills, 102 Duff Road, Penn Hills, PA 15235 by 10:30 a.m. prevailing time, on February 26, 2021. Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words "**PENN HILLS 2021 CCTV INSPECTION CONTRACTS**"

Copies of Drawings, Specifications, Mapping, Instructions to Bidders, General Conditions, Forms of Proposals and Agreement are on file and open to public inspection at the Penn Hills Purchasing Office, located at 102 Duff Road, Penn Hills, PA 15235 where sets of said documents may be obtained upon payment of \$75.00 per set of the CCTV contract. No refund will be made for the return of any documents.

Pennsylvania Prevailing Wage rates **are not** required to be paid on Penn Hills 2021 CCTV Inspections Contract.

**There will be a Penn Hills 2021 CCTV Inspection Contracts MANDATORY pre-bid meeting on February 16, 2021 at 10:00 AM. at the Municipality of Penn Hills, 102 Duff Road, Penn Hills, PA 15235. Contractors who intend to bid any of the individual Contracts MUST attend the pre-bid meeting to be eligible to bid the contract.**

Proposals must be submitted on the forms provided by the Municipality of Penn Hills. Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of the Municipality of Penn Hills in an amount equal to ten percent (10%) of the total amount of the Proposal for each separate contract as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within fifteen (15) days after Notice of the Award of the Contract. The Proposals must be made to the Municipality of Penn Hills, Allegheny County, Pennsylvania, and shall remain firm for a period of sixty (60) days. No Bidder may withdraw his Proposal during the sixty (60) day period without forfeiting his Bid guarantee. Performance, Maintenance, and Labor and Material Payment Bonds, along with Public Liability and Property Damage Certificates of Insurance in the amounts specified, as well as Certificates of Workman's Compensation must be filed with the executed Agreement upon acceptance of the Proposal from the successful Bidder.

The Owner reserves the right to reject any or all Proposals, or any part thereof, for any reason, and also reserves the right to waive any informality therein.
