

PENN HILLS COUNCIL MEETING  
December 21, 2020  
7:00PM

1. Approval of Agenda Items. The meeting convened at 7:00PM, in person at the Municipal Center and virtually. The mayor announced there were no agenda changes. The mayor announced that an executive session was held on December 14, 2020.
2. Pledge of Allegiance. The mayor led the Pledge of Allegiance.
3. Roll Call. Roll was called and Councilors Getsy, Petrucci and Pecora were present. Mayor Calabrese and Deputy Mayor Sapp were also present.
4. Approval of Expenses. Mayor Calabrese called for a motion to approve the expenses. The motion was made by Councilman Petrucci and seconded by Deputy Mayor Sapp.
5. Western Penn Hills Community Action, Inc. presented the Mayor and Council with information about their summer work and employment program.
6. Mayor Calabrese asked for Public Comment on Agenda Items. There was no public comment on any agenda item.

**OLD BUSINESS:**

Mayor Calabrese asked for a motion to approve Ordinance 2020-2678. A motion was made by Councilman Petrucci to approve Ordinance 2020-2678, Authorizing the Execution of a Cable Franchise Agreement Between the Municipality and Verizon Pennsylvania, LLC. The motion was seconded by Deputy Mayor Sapp. The Mayor invited comments from Council. Roll was called. Ordinance 2020-2678 was unanimously approved.

**NEW BUSINESS:**

7. Mayor Calabrese asked for a motion to approve Resolution 2020-57. A motion was made by Councilman Petrucci to approve Resolution 2020-57, Awarding Demolition of Blighted and Condemned Structures for Municipal-Wide Demolition Program of the CDBG Program. The motion was seconded by Councilman Getsy. Mayor Calabrese invited comments from Council. Roll was called. Resolution 2020-57 was approved unanimously.

8. Mayor Calabrese asked for a motion to approve Ordinance 2020-2680. A motion was made by Councilman Petrucci to approve Ordinance 2020-2680, Adopting the Operating Budget and Establishing Real Estate Tax Rates for 2021. The motion was seconded by Councilman Pecora. Mayor Calabrese invited comments from Council. Roll was called. Ordinance 2020-2680 Mayor Calabrese, Deputy Mayor Sapp, Councilman Pecora and Councilman Pecora voted in the affirmative.

Councilman Getsy voted no.

9. Mayor Calabrese asked for a motion to approve the 2021 Meeting Schedule. A motion was made by Councilman Petrucci to approve the 2021 Meeting Schedule for Council. The motion was seconded by Deputy Mayor Sapp. Mayor Calabrese invited comments from Council. Roll was called. The 2021 Calendar of Meetings was approved unanimously.

10. Mayor Calabrese asked for a motion to approve a grant Agreement with ALCOSAN. A motion was made by Councilman Petrucci. The motion was seconded by Councilman Pecora. The Mayor invited comments from Council. Roll was called. The Grant Agreement with ALCOSAN was approved unanimously.

11. Mayor Calabrese called for a motion to table a Transit Shelter Agreement Between Lamar Advertising of Pittsburgh and the Municipality of Penn Hills for a ten-year term beginning August 1, 2020. Councilman Petrucci made a motion to table to the item. Deputy Mayor Sapp seconded the motion to table. Roll was called. The motion to table the item was approved unanimously.

12. Councilman Petrucci made a motion to approve the eligibility list for police hiring. Councilman Getsy seconded the motion. Mayor Calabrese invited comments from Council. Roll was called. The Certified Eligibility List for Police Officer Hiring was approved unanimously.

Resident Carolyn Pandolfo addressed the Mayor and Council concerning a dispute between residents on Atlas Drive.
